The State Bar of Georgia has added the Assessments and the Legislative & Public Education Fund contribution to the dues amount in Section A. Read about the Mandatory Assessments and Legislative & Advocacy Fund below:

**Assessments-Mandatory:**

**Clients' Security Fund (CSF)** - Provides a remedy of last resort for clients whose funds were mishandled by their attorney (\$100 maximum - paid in full at enrollment). See Rule 1-506.

**Bar Facility Assessment (BFA)** - Used to purchase, maintain and operate State Bar offices (\$200 maximum - paid in full at enrollment). See Rule 1-507.

**Legislative & Public Education Fund-Optional \$100:**

Allows the Bar to maintain a strong and active voice on behalf of its members in supporting or opposing issues of importance to the administration of justice in Georgia.

**Georgia Legal Services Program:**

Your GLSP donation is tax deductible. This program provides civil legal services for Georgia's poorest residents and helps guarantee equal access to justice, so please give generously. The suggested donation is \$250.

**Notice Regarding Deductibility:**

Pursuant to Sections 162(e) and 6033(e) of the Internal Revenue Code, certain lobbying and political expenses are not deductible and information concerning their non-deductibility must be communicated by tax-exempt organizations to their members. In compliance with these requirements, you are hereby notified that the \$100 voluntary contribution to the Legislative & Public Education Fund is **not tax deductible**.
